RESOLUTION AMENDING STAFFING LEVELS AND PAY RATES FOR FISCAL YEAR ENDING DECEMBER 31, 2014

WHEREAS, The Ohio Revised Code authorizes the appointment of Township Employees and the fixing of their compensation by a Board of Township Trustees.

BE IT RESOLVED, by the Trustees of Ross Township, Butler County, Ohio, as follows:

SECTION 1:

To provide for staffing levels for Ross Township during the fiscal year ending December 31, 2014, the staffing levels and pay rates established as shown on Exhibit "A".

SECTION 2:

This Resolution shall take effect retroactively on January 12, 2014, upon the filing of this Resolution with the Ross Township Fiscal Officer.

SECTION 3:





³ All Fire Department Volunteers are paid thru a point system as follows: \$6.00 per point - 2 points awarded per run.

⁴ The pay range for personnel with the designation of Part Time Laborer is determined by the Board of Trustees and can be based on the recommendation of the Road Superintendent based on the experience level of the applicant.
