



# ROSS TOWNSHIP RESOLUTION

## RESOLUTION NUMBER 2015-006

### RESOLUTION AMENDING REVENUE IN VARIOUS FUNDS, AND REQUESTING AN AMENDED CERTIFICATE OF ESTIMATED RESOURCES FROM THE BUTLER COUNTY AUDITOR

WHEREAS, R.C. 5705.40 authorizes the amendment or supplement of revenue and appropriations and provides that transfers may be made by resolution from one appropriation item to another, and

WHEREAS, the changes to the budget of Ross Township necessitated by this resolution require that the Butler County Auditor produce and deliver an Amended Certificate of Estimated Resources.

BE IT RESOLVED by the Trustees of Ross Township, Butler County, Ohio, pursuant to Section 5705.40 of the Ohio Revised Code, as follows:

#### SECTION 1-A:

To make provision for the current expenses and other expenditures of said Board of Trustees, during the fiscal year ending December 31, 2014, revenues be amended in accordance with the attached Exhibit "A" which is incorporated herein by reference as if fully rewritten.

#### SECTION 1-B:

That the Fiscal Officer of Ross Township hereby be directed to request an Amended Certificate of Estimated Resources from the Butler County Auditor.

#### SECTION 2-A:

That Section 1-A of this resolution shall take effect upon receipt of the Amended Certificate of Estimated Resources from the Butler County Budget Commission.

#### SECTION 2-B:

This all other aspects of this resolution shall take effect on January 7, 2015 following the filing of this resolution with the Ross Township Fiscal Officer.

**SECTION 3:**



**INTRODUCTION AND VOTE RECORD:**






