RESOLUTION NUMBER 2015-039

RESOLUTION REQUESTING CONSIDERATION OF THE DIRECTOR OF HIGHWAYS FOR REDUCTION OF THE EXISTING PRIMA FACIA SPEED LIMIT ON SKYMEADOWS DRIVE IN ROSS TOWNSHIP

WHEREAS, a request has been made to this Board that the statutory vehicular speed limit established by Sec. 4511.21, Revised Code of Ohio is greater than that considered reasonable and safe on Sky Meadow Drive beginning at Smith Road and continuing South 0.563 Miles to the Dead End and;

WHEREAS, this Board has caused to be made an engineering and traffic investigation upon the section of road described above, and

WHEREAS, it is the belief of this Board that such investigation confirms the allegation that the statutory speed limit of 55 mph is unrealistic.

NOW THEREFORE, BE IT RESOLVED by the Board of Ross Township Trustees, Butler County, Ohio that:

SECTION 1-A: That by virtue of the provisions of Sec. 4511.21, Revised Code of Ohio, the Director of Highways is hereby requested to review the engineering and traffic investigation and to determine and declare a reasonable and safe prima facie speed limit on Sky Meadow Drive beginning at Smith Road and continuing South 0.563 Miles to the Dead End in Butler County, Ohio.

SECTION 1-B: That when this Board is advised that the Director of Highways has determined and declared a reasonable and safe speed limit on the section of road described in Section 1-A hereof, standard signs, properly posted and giving notice thereof will be erected.

SECTION 2:

This resolution shall take effect on July 2, 2015 following the filing of this resolution with the Ross Township Fiscal Officer.

SECTION 3:






