



# ROSS TOWNSHIP RESOLUTION

## RESOLUTION NUMBER 2015-048

### RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION, AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

**WHEREAS**, the Board of Trustees of Ross Township, Butler County, Ohio, in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2016; and

**WHEREAS**, the Budget Commission of Butler County, Ohio has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board and what part thereof is without, and what part within, the ten mill tax limitation.

**BE IT RESOLVED** by the Trustees of Ross Township, Butler County, Ohio, pursuant to Sections 5705.34 and 5705.35 of the Revised Code, as follows:

#### **SECTION 1-A:**

That the amounts and rates, as determined by the Budget Commission in its certification, be and are the same and hereby accepted; and

#### **SECTION 1-B:**

That there be and is hereby levied on the tax duplicate of said Township the rate of each tax necessary to be levied within and without the ten mill limitation per the attached Schedule A and Schedule B; and

#### **SECTION 1-C:**

That the Fiscal Officer of this Board be and hereby is directed to certify a copy of this Resolution to the County Auditor of Butler County, Ohio.

#### **SECTION 2:**

This resolution shall take effect on August 20, 2015 upon the filing of this resolution with the Ross Township Fiscal Officer.

#### **SECTION 3:**

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings


open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


