RESOLUTION NUMBER 2015-053

**RESOLUTION DECLARING A NUISANCE FOR ACCUMULATED DEBRIS,
EXCESSIVE VEGETATION AND/OR JUNK MOTOR VEHICLE AT 2181 BEECHWOOD
DRIVE, 2255 BELLA VISTA DRIVE, 2364 ROBIN AVENUE, 4032 LARK
STREET AND 2182 THRUSH AVENUE**

WHEREAS, Section 505.87 of the Ohio Revised Code authorizes the Board of Trustees to abate, control or remove vegetation, garbage, refuse or other debris determined to constitute a nuisance ("nuisance" or "nuisance conditions"); and

WHEREAS, Section 505.871 of the Ohio Revised Code authorizes the Board of Trustees to provide for the removal of junk motor vehicles from public or private property in the Township ("junk motor vehicles"); and

WHEREAS, the Ross Township Administrator has received information concerning accumulated debris, excessive vegetation or junk motor vehicle(s) located at 2181 Beechwood Drive, 2255 Bella Vista Drive, 2364 Robin Avenue, 4032 Lark Street; and 2182 Thrush Avenue.

WHEREAS, the Ross Township Administrator has inspected the subject premises and the Ross Township Board of Trustees has determined that it contains accumulated debris, excessive vegetation or junk motor vehicle(s);

BE IT RESOLVED by the Board of Trustees of Ross Township, Butler County, Ohio, pursuant to Section 505.87 and Section 505.871 of the Revised Code, as follows:

SECTION 1-A:

That based upon the evidence presented the Board of Trustees finds that the accumulated debris, excessive vegetation or junk motor vehicle(s) located at the premises known as 2181 Beechwood Drive, premises also known as K4620-062-000-039 of the Butler County Auditor's Tax Plats; also at the premises known as 2255 Bella Vista Drive, premises also known as K4620-062-000-016 and K4620-062-000-031 of the Butler County Auditor's Tax Plats; also at the premises known as 2364 Robin Avenue, premises also known as K4620-061-000-018, K4620-061-000-019 and K4620-061-000-020,

of the Butler County Auditor's Tax Plats; also at the premises known as 4032 Lark Street, premises also known as K4620-062-000-025 of the Butler County Auditor's Tax Plats; and also at the premises known as 2182 Thrush Avenue, premises also known as K4620-064-000-079, K4620-064-000-078, K4620-064-000-077, K4620-064-000-076, K4620-064-000-075, K4620-064-000-074 & K4620-064-000-073 of the Butler County Auditor's Tax Plats; constitutes a nuisance at each parcel and as such is detrimental to the health, safety and general welfare of all persons who live, work or own property within Ross Township and accordingly are hereby declared nuisances.

SECTION 1-B:

That the Ross Township Administrator is hereby directed to abate each nuisance in full compliance with Section 505.87 and Section 505.871 of the Ohio Revised Code including but not limited to notice to the owner and record lien holders that the owner is to remove all accumulated debris; cut and remove all excessive vegetation and remove any junk motor vehicle within the time specified and that upon the owner's failure to failure to comply with this resolution, the Board of Trustees will provide for the abatement of the nuisance and that any expenses incurred by the Board of Trustees will be assessed to the owner's property.

SECTION 2:

This resolution shall take effect on August 20, 2015 upon the filing of this resolution with the Ross Township Fiscal Officer.

SECTION 3:






