RESOLUTION AMENDING STAFFING LEVELS AND PAY RATES FOR FISCAL YEAR ENDING DECEMBER 31, 2015

WHEREAS, The Ohio Revised Code authorizes the appointment of Township Employees and the fixing of their compensation by a Board of Township Trustees.

BE IT RESOLVED, by the Trustees of Ross Township, Butler County, Ohio, as follows:

SECTION 1:

To provide for staffing levels for Ross Township during the fiscal year ending December 31, 2015, the staffing levels and pay rates are herein amended as shown on Exhibit "A".

SECTION 2:

This Resolution shall take effect on November 5, 2015 with the filing of this Resolution with the Ross Township Fiscal Officer.

SECTION 3:

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


