## ROSS TOWNSHIP RESOLUTION

### RESOLUTION NUMBER 2016-001

RESOLUTION SETTING THE AMOUNT FOR PURCHASES REQUIRING A PURCHASE ORDERS; GRANTING AUTHORITY TO THE FISCAL OFFICER TO MOVE FUNDING FROM ONE LINE ITEM TO ANOTHER WITHIN THE SAME FUND; AUTHORIZING TRANSFER OF \$14,652.00 FROM THE GENERAL FUND OF ROSS TOWNSHIP TO ITS POLICE DISTRICT FUND PURSUANT TO R.C. 5705.14(E) AND REQUESTING AN AMENDED CERTIFICATE OF ESTIMATED RESOURCES FROM THE BUTLER COUNTY AUDITOR

WHEREAS, Section 507.11 O.R.C. allows the Ross Township Board of Trustees to authorize Township employees to incur obligations on behalf of the Township; and

WHEREAS, R.C. 5705.40(E) provides that transfers may be made by resolution from the General Fund to any other Ross Township fund; and

WHEREAS, Section 5705.38 provides for the appropriation of funds for Township expenditures; and

WHEREAS, the Ross Township Board of Trustees desire to grant permission for the Fiscal Officer to move funding, from one line item to another, within the same fund.

**BE IT RESOLVED** by the Trustees of Ross Township, Butler County, Ohio, pursuant to Chapters 507 and 5705 of the Ohio Revised Code, as follows:

#### SECTION 1-A:

The Board of Trustees herein require the acquisition of a "Purchase Order" for any purchase made on behalf of the Township by its' employees in excess of \$1,000.00.

#### SECTION 1-B:

The Board of Trustees hereby grants the Fiscal Officer the authority to move funding, from one line item to another, within the same fund during Fiscal Year 2016.

#### SECTION 1-C:

That the Board of Trustees of Ross Township hereby authorizes the transfer of money from the General Fund to Fund 2081-Police District in the amount of \$14,652.00 which is equal to the amount collected in the previous year for fines and fees from traffic tickets written by the Ross Township Police Department.

#### SECTION 1-D:

That the Fiscal Officer of Ross Township hereby be directed to request an Amended Certificate of Estimated Resources from the Butler County Auditor.

#### SECTION 2 A:

That Sections 1-A, 1-B and 1-D of this resolution shall take effect retro-actively on January 1, 2016 following the filing of this resolution with the Ross Township Fiscal Officer.

#### SECTION 2:

That Sections 1-C of this resolution shall take effect upon receipt of the Amended Certificate of Estimated Resources from the Butler County Budget Commission.

#### SECTION 3:

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
