



ROSS TOWNSHIP RESOLUTION NUMBER 2017-029

RESOLUTION AMENDING REVENUE IN VARIOUS FUNDS, AND REQUESTING AN AMENDED CERTIFICATE OF ESTIMATED RESOURCES FROM THE BUTLER COUNTY AUDITOR

WHEREAS, R.C. 5705.40 authorizes the amendment or supplement of revenue and appropriations and provides that transfers may be made by resolution from one appropriation item to another, and

WHEREAS, the changes to the budget of Ross Township necessitated by this resolution require that the Butler County Auditor produce and deliver an Amended Certificate of Estimated Resources.

BE IT RESOLVED by the Trustees of Ross Township, Butler County, Ohio, pursuant to Section 5705.40 of the Ohio Revised Code, as follows:

SECTION 1-A:

To make provision for the current expenses and other expenditures of said Board of Trustees, during the fiscal year ending December 31, 2017, revenues be amended in accordance with the attached Exhibit "A" which is incorporated herein by reference as if fully rewritten.

SECTION 1-B:

That the Fiscal Officer of Ross Township hereby be directed to request an Amended Certificate of Estimated Resources from the Butler County Auditor.

SECTION 2-A:

That Section 1-A of this resolution shall take effect upon receipt of the Amended Certificate of Estimated Resources from the Butler County Budget Commission.

SECTION 2-B:

This all other aspects of this resolution shall take effect on June 15, 2017 following the filing of this resolution with the Ross Township Fiscal Officer.

SECTION 3:

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings

open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
