The Ross Township Board of Trustees met in regular session to transact business for Ross Township.

ROLL CALL

PROCEDURAL ACTION

Fiscal Officer Judy Huffman, reported as of this date the township has on deposit \$3,662,933.97. She provided the Board with copies of the Bank Reconciliation Statement and the Fund Summary Report for September, 2014.

A presentation was given by David Brown, Butler County Auditor's Office, who advised the successful completion of the biennial property appraisals advised that homeowners are encouraged to apply for a formal review if they feel that the appraised value needs to be disputed. Disputes may be made by phone or through the website portal. He also noted that the Auditor returned 1.93 million dollars to local governments in 2014. Speaking as a member of the Ross Local School District Board he noted that the Board is very pleased with the Police Department and the SRO program and that they will be working to correct some misinformation that is circulating regarding the SRO activity.

DEPARTMENT REPORTS

Administration - Administrator Bob Bass reported that all nuisances are currently closed. He also reminded the Board of the upcoming deadline for the 2015 CDBG application.

Fire Department - Chief Steve Miller presented the monthly report for September, 2014. He announced the retirement of the departments Medical Director, Dr Arthur Walls, M.D. and thanked him for his many years of outstanding service to the community having never requested to be paid for his service. Additionally, he announced the new Medical Director as Dr Conal Roush, M.D.

Finally, he advised that he attended the Open House Forest Run Park in the Timberman Ridge area of Ross Township which is a new Butler County MetroPark with 3.7 miles of walking trails.

Road Department

Superintendent Paul Bulach provided the Board with an update on outstanding right-of-way issues and winter equipment servicing. He also reported that part of Ross Trails will be crack sealed as a condition of the expiring bond.

Police Department - Chief Darryl Haussler presented the monthly report for September, 2014.

OLD BUSINESS

The Police Chief reported that engine brake signage may be placed by resolution in Ross Township. The Township must then buy the signage and ODOT will place them on state right-of-way. The Police Department may cite violators under R.C. 4511.12. Trustee Willsey will meet with the Administrator to lay out the zones for this purpose and the Administrator will prepare a resolution for the next meeting after conferring with Trustees Yordy and Wurzelbacher individually on the zone locations. The Police Chief was instructed to alert the Municipal Court on the matter.

Trustee Yordy provided an update on request for multi-way stop sign at the intersection of Venice and Lark noting that the Butler County Engineer felt the signs unnecessary. The Engineer observed the need to remove several bushes to cure a sight visibility problem issue at the intersection and the Road Superintendent was instructed to make sure that the removal took place.
